

## IMPORTANT DISCLAIMER: INTERNET FRAUD ALERT

Amundi Hong Kong Limited ("Amundi Hong Kong") and Amundi Private Fund Management (Beijing) Co. Ltd. ("Amundi Beijing"), both of which are within the Amundi Asset Management Group, noticed the existence of mobile applications (APP) or electronic platforms (e.g., online communication software) that have committed fraud by impersonating the Amundi Asset Management Group and promoting counterfeit investment products or investment advisory services of the Amundi Asset Management Group.

The Amundi Asset Management Group, Amundi Hong Kong and Amundi Beijing do not and will not sell investment products to investors in Mainland China and Hong Kong through our Application, nor have we and will we receive any payment from investors through our Application.

The Amundi Asset Management Group hereby reminds clients and the public to stay alert to the authenticity and reliability of information published on APPs, electronic platforms and websites (collectively, "Application"), be alert to fraudulent news published on the Application, pay attention to the safety of funds, and avoid making investments and payments on unreliable and unsafe Application.

The Amundi Asset Management Group hereby clarifies that only the following three official channels to access information of the Amundi Asset Management Group are available in the public domain in Mainland China and/or Hong Kong.
